

RULES AND REGULATIONS OF THE MASS EVENT

International Mini Meeting 2026

Leszno Airfield, May 28 – June 1, 2026

§1 General Provisions

1. These Rules and Regulations define the terms of participation and conduct during the mass event called **International Mini Meeting 2026** (hereinafter: the “Event”), which will take place at the Leszno Airfield from **May 28 to June 1, 2026**.
2. The Event is organized by **IMM.PL Sp. z o.o.** (hereinafter: the “Organizer”).
3. The purpose of these Rules and Regulations is to ensure safety and order during the Event, and to define the rights and responsibilities of participants.
4. Entering the Event area implies full acceptance of these Rules and Regulations.

§2 Entry to the Event Area

1. Access to the Event area is granted to individuals who:
 - possess a **valid entry ticket or accreditation**, and
 - present a **valid ID** upon request.
2. Children under the age of 16 may attend the Event **only under adult supervision**.
3. The Organizer reserves the right to refuse entry to or remove from the Event area any persons who:
 - are **intoxicated or under the influence** of drugs or intoxicating substances,
 - behave **aggressively** or pose a threat to others,
 - **violate** these Rules and Regulations.

§3 Prohibited Conduct

The following are **strictly prohibited** within the Event area:

1. Bringing in:
 - **firearms**, gas or pneumatic weapons, or sharp objects,
 - **explosives** or pyrotechnic materials,
 - **drugs or psychoactive substances**,
 - **alcoholic beverages** (unless purchased within the Event premises),
 - **private sound systems** (e.g., large speakers, generators),
 - **drones**, unless prior **written consent** has been obtained from the Organizer.

2. Lighting bonfires or using open flames **outside of designated areas**.
3. Driving vehicles **outside of designated zones**.
4. **Conducting trade or providing services** without prior approval from the Organizer.
5. **Littering** on the Event grounds.
6. **Disturbing public order or damaging property**.

§4 Participant Obligations

1. All Event participants are required to:
 - comply with instructions from the **Organizer, security, and event staff**,
 - keep the Event area **clean and orderly**,
 - observe **health and safety (H&S)** and **fire protection (fire safety)** regulations,
 - **respect** the property of other participants and the Organizer,
 - behave in a manner that does **not disrupt the Event**.
2. Participation in the Event is **at the participant's own risk**.

§5 Safety Regulations

1. The Event area is monitored by **security services** and **CCTV surveillance**.
2. In the event of an emergency or safety threat, participants must **immediately follow** all instructions given by the Organizer, emergency services, or security personnel.
3. The Organizer is **not responsible** for any lost, stolen, or unattended belongings.

§6 Liability

1. Participants are **civilly and criminally liable** for any damage caused to third parties, property, or the Organizer.
2. The Organizer bears **no liability** for accidents resulting from the participant's failure to comply with these Rules and Regulations.

§7 Final Provisions

1. The Organizer reserves the right to:
 - **change the Event program**, and/or
 - **interrupt or cancel** the Event due to reasons beyond their control (e.g., weather conditions, safety concerns).

2. These Rules and Regulations are available:
 - on the **Organizer's website**,
 - at the **entrance** to the Event area,
 - at **information points** within the Event grounds.
3. Any matters not covered by these Rules and Regulations shall be **decided solely by the Organizer**.
